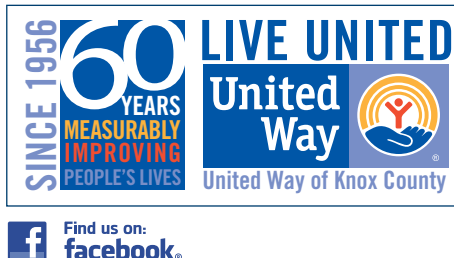

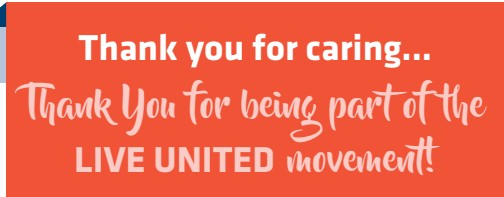

DESIGNATION POLICY

Other United Ways and Non Partner Agencies

Designations are not necessary, however, if you designate your contribution, please follow these required guidelines:

- Must be a minimum of \$50 per designation
- Designation must be a 501c3 Not-for-Profit, Health & Human Service Organization recognized by the IRS and not on the Homeland Security Watch List
- You must write in the agency's name, address, city and state
- Only after organization verification, meeting the standards, and receipt of the funds, will money be sent
- An administration and campaign cost fee of 12% will be deducted from all non-partner agencies
- Designations not meeting the requirements will be redirected to the Community Impact Fund of United Way of Knox County

We partner with **25 agencies** and participate in **27 programs** in Knox County.

The United Way is funding Knox County's Kindergarten Jump Start for **2 additional years**. In the last two years, **152 students** attended Jump Start.

120 students in Kindergarten through 3rd grade received tutoring from their teachers. This program will be fully funded for **3 additional years**, thanks to your help!



United Way held **5 Community Conversations** in 2015, with **10 more** scheduled for 2016.

We developed the **Knox County Charity Tracker** network which tracks charitable donation spending.

85% of brain growth happens between children ages **0 to 3 years old**. We are sponsoring an Early Childhood Brain Development Symposium on **September 14, 2016** at Vincennes University.
