## DESIGNATION POLICY

### Other United Ways and Non Partner Agencies

Designations are not necessary, but, if you designate your contribution, please follow these required guidelines:

- Designation must be a 501c3 Not-for-Profit, Health & Human Service Organization recognized by the IRS and not on the Homeland Security Watch List
- You must write in the agency's name, address, city and state
- Only after organization verification, meeting the standards, and receipt of the funds, will money be sent
- An administration and campaign cost fee of 15% will be deducted from all non-partner agencies
- Designations not meeting the requirements will be redirected to the Community Impact Fund of United Way of Knox County
- Must be a minimum of \$50 per designation
